On January 27, 2012, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Fort Calhoun Station. The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report documents the inspection results which were discussed on January 27, 2012, with you and other members of your staff.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

The inspection does not address closure of specific security actions related to the Confirmatory Action Letter, dated September 2, 2011. The NRC plans to address those items in future inspections.

No findings were identified during this inspection.
