Fuel assembly kits and grid straps will be used to demonstrate that CBNF's manufacturing process is capable and qualified to manufacture AP1000 nuclear fuel assemblies that meet the Westinghouse design and product specifications. After qualification is complete, the products that result from the use of the fuel assembly kits and straps will not be used in any nuclear reactor. Additionally, these products will be scrapped unless a future amendment to this license is made to designate an authorized end user of the non-fuel bearing products (replica) that result from the use of the fuel assembly kits and grid straps.
