This is in reference to Section V, Condition A.1 of Confirmatory Order EA-11-043 (Order), in which Accurate NDE & Inspection, LLC (Accurate NDE) was required to contract with an external contractor to provide training to all of its current employees who are engaged in NRC-licensed activities. In accordance with conditions of the Order, Accurate NDE submitted for NRC review the name and resume of the contractor recommended to perform the training, and an outline of the topics to be covered during this training session. This was submitted by email dated January 16, 2012.
