Dear Mr. Conant:

As requested by your letter, dated December 21, 2011, the NRC has terminated NRC License No. SNM-1067, under License Amendment No. 18 which is enclosed with this letter. This termination is being issued in accordance with the requirements of the applicable NRC License Termination Rule 10 CFR 70.38.

In your letter dated September 2, 2011, you submitted a revised Decommissioning Funding Plan (DFP) for your NRC licenses SNM-1067 and 06-00217-06 that requested that the financial assurance amount be reduced because you have completed a substantial amount of decommissioning work at the site. Because your current and revised DFP reference both licenses; administratively, the NRC assigned separate mail control numbers for each license for this request, (575938 for your SNM-1067 license and 575937 for your 06-00217-06 license.) Because the SNM-1067 license has been terminated, we will void the DFP revision action for the SNM-1067 license, mail control No. 575938 that we administratively created. Because we have terminated License No. SNM-1067, we understand that you will reference only the 06-00217-06 license in the revised financial assurance documents that you will submit for our review in response to our letter dated January 18, 2012. Following receipt of acceptable financial assurance documents, we will return any superseded financial assurance documents to you.

Termination of the SNM-1067 license does not allow areas of the ABB Inc. CE Windsor, Connecticut site to be released for unrestricted use because NRC license No. 06-00217-06 remains in effect for the site. Decommissioning activities will continue under that license.
