

The purpose of this modification is to (1) exercise the second, third and fourth option years in accordance with FAR clause 52-217-19, entitled "Option to Extend the Term of the Contract, thereby extending the contract period of performance through March 16, 2015 and (2) provide funding in the amount of **\$30,000.00** thereby increasing the obligation amount from \$64,908.80 to **\$94,908.80**, and (3) increase the ceiling by \$89,826.00 from \$22,908 to **\$112,784.00**

Accordingly, the following section paragraph 1 is hereby revised to read as follows

B.5 CONSIDERATION AND OBLIGATION—DELIVERY ORDERS (JUNE 1988)

"a" The total estimated amount of contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is **\$112,784.00**

"b" the amount presently obligated with respect to this contract is **\$94,908.80**.

Accordingly, the following section paragraph 1 is hereby revised to read as follows:

B.6 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUNE 1988)

The ordering period for this contract shall commence on March 17, 2010 and will expire on **March 16, 2015**

Option 2 – From March 17, 2012 to March 16, 2013 is hereby exercised.

Option 3 – From March 17, 2013 to March 16, 2014 is hereby exercised.

Option 4 – From March 17, 2014 to March 16, 2015 is hereby exercised

Accordingly, the following section of the contract is hereby modified:

C.5 52.217-9 OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 2000)

(a) The Government may extend the term of this contract by written notice to the Contractor within 60 days; provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least 30 days before the contract expires. The preliminary notice does not commit the Government to an extension.

(b) If the Government exercises this option, the extended contract shall be considered to include this option clause.

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed **March 16, 2015**.

C.6 52.232-19 AVAILABILITY OF FUNDS FOR THE NEXT FISCAL YEAR (APR 1984)

Funds are not presently available for performance under this contract beyond **3/16/15**. The Government's obligation for performance of this contract beyond that date is contingent upon the availability of appropriated funds from which payment for contract purposes can be made. No legal liability on the part of the Government for any payment may arise for performance under this contract beyond **3/16/15**, until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer.
