SUBJECT: APPLICATION FOR NRC IMPORT LICENSE (IW031)

Enclosed for your consideration is an application, dated February 14, 2012 (Enclosure 1), received by the U.S. Nuclear Regulatory Commission (NRC) from Perma-Fix Northwest Richland, Inc. for a proposed import of radioactive waste from the Laguna Verde Nuclear Power Plant in Mexico. We are sending an analogous letter to Mr. Terry Frazee, State of Washington, for his consideration.

The applicant is requesting a license to allow the import of up to 500 tons of radioactively contaminated combustible materials for volume reduction via thermal destruction at the Perma-Fix Northwest Richland, Inc. Richland, WA site. The applicant is also requesting a license to export (return) the ash generated from the process of thermal destruction, along with containers and any nonconforming material not valid for alternate processing, back to Mexico, the country of the origin, XW019 (Enclosure 2).

The import application (IW031) was forwarded to the U.S. Department of State (DOS) on February 24, 2012, for assistance in notifying the Mexican Government authorities of the proposed radioactive waste import in the U.S. NRC also requested DOS's views as to whether issuing the license would be consistent with the Joint Convention on the Safety of Spent Fuel Management and Safety of Radioactive Waste Management. A Federal Register notice regarding both import and export license applications will be published in the near future.

It would be greatly appreciated if within three weeks of the date of this letter, you could respond with any comments you may have concerning the import license application (IW031) or if necessary, provide an estimate of how much additional time may be required to complete your review and provide a written response to NRC.
