This letter is to notify the Commission about a change of ownership of Memorial Hospital of South Bend, IN.

Memorial Hospital and Health System and Elkhart General Healthcare System have agreed to form an affiliation. Under the agreement, a new (currently unnamed) healthcare system has been formed to create a new parent company that will operate both Memorial Hospital and Elkhart General Hospital. The affiliation will include an equal number of Board members from each existing organization to form the new system entity. Each hospital will retain its separate Board and report to the new system entity. Both Memorial Hospital and Elkhart General Hospital will operate at their existing locations. The new corporate office for the parent company will operate at a new location convenient to both hospitals, but that location is unknown at this time. Both Memorial Hospital and Elkhart General Hospital will continue to operate as not-for-profit, community-owned organizations. Neither hospital is being acquired by the other. There was no exchange of funds or assets between the two organizations.

Currently, there will be no changes in personnel or duties related to the licensed program at Memorial Hospital.

Currently, there will be no changes in the organization, location, facilities, equipment, or procedures that relate to the licensed program at Memorial Hospital.

There will be no changes to the surveillance program (surveys, wipe tests, quality control) at Memorial Hospital.
