2) Physical Description

This shipment will consist of 126 drums of Uranium Ore Concentrate (U-308) in 2 x 20' ocean containers. The total weight of the shipment is 27,318.2 kgs of U-308.

3) Transportation and Route Schedule

The vessel sailed from Adelaide on December 20, 2011. The ocean transportation from Adelaide to Seattle, WA USA will be the responsibility of Hapag Lloyd.
