Dear Administrative Judges:

In its Order dated March 5, 2009, the Atomic Safety and Licensing Board ("Board") directed the NRC staff ("Staff") to tender each month a status report advising as to whether the estimated dates for issuance of the final Safety Evaluation Report ("SER") (predicted for the late summer of 2009) and the final environmental review document (predicted for December of 2009) have changed.¹ The Staff expects to issue the SER by May 2012. While the Staff continues to expect at this time to issue the final environmental review document by August 2012, the Staff would note that there is a possibility of delay (up to six months) due to time potentially needed to accomplish activities pursuant to Section 106 of the National Historic Preservation Act.

In keeping with the Board's mandate, the Staff will tender its next monthly status report by April 16, 2012.
