

This entity, Zion Solutions LLC, a U.S. Nuclear Regulatory Commission licensee, is duly and currently legally registered in the State of Delaware - File # 4328400 as a Domestic LLC entity and additionally registered in the State of Illinois (location of the Zion Decommissioning Project) File # 02181177 as a Foreign LLC entity. An LLC is defined as a Limited Liability Company by respective state statutes. Documents as previously described in this communication and requested by this Freedom of Information Act request are usually not required to be filed with the State Jurisdictions but more likely than not were examined in detail and retained for licensee reference purposes by the U.S. Nuclear Regulatory Commission in its mission role as a Federal Regulator and under dictates of the formal review process undertaken by the U.S. Nuclear Regulatory Commission in recent years.

We believe that the public in Illinois is entitled to be informed on business details related to Membership Interests in LLC business structures and the Directorships that have an impact on the affairs of licensees and the public they serve. We also believe that this project calls for a higher standard of disclosure and transparency where a U.S. Nuclear Regulatory Commission license has been transferred to a non-public utility under a new decommissioning model where decommissioning trust funds have been set aside by the public in the rate paying system in order to effectively and efficiently address the project tasks moving forward in a complex multi-year project with almost a \$ 1.0 billion dollar capital budget for the Zion Decommissioning & Site Restoration Project.

Vista 360 Community Solutions Service Background

Vista 360 is a volunteer nonprofit Leadership group involved with problem solving issues that have a public dimension. We are composed of scientists, engineers, business executives and academics who unilaterally and independently engage issues that have a potential impact on the public.

All volunteer participants are welcome but in essence, we are skills based critical thinkers who bring decades of work history, knowledge capital and life experiences to problem identification, definition, resolution and solution. As citizen experts, Vista 360 believes it can make a constructive positive contribution to problem solving complex issues in the public domain where actionable plans come into play.

Since 2007, Vista 360 has been engaged in the proposed License Transfer & Decommissioning of the Zion Nuclear Power Station which is an Exelon Corporation asset. The currently pending transaction between Exelon Corporation and Energy Solutions, Inc. and as reviewed by the U.S. Nuclear Regulatory Commission involves the unprecedented License Transfer and then the multi-year Decommissioning of the Zion Facility using a dedicated Decommissioning Trust Fund that has been financed by the rate paying public in the Northern Illinois service area. The Zion Nuclear Power Station Decommissioning Trust Funds have currently accrued to a level of \$ 890,000,000 as of July 30th, 2010 which will be drawn down to meet the capital needs of the project.

Transparency and full disclosure have been ongoing challenges since the conceptual onset of the innovative Decommissioning model which is now pending. Vista 360 is NOT anti-nuclear, anti-utility, anti-contractor or anti-plan as we understand it. We are pro-public and feel that this segment of the stakeholder universe has been marginalized by the system and the proposed business model for the project so we have been working on an engagement strategy that addresses the upcoming Decommissioning term which will begin shortly and unfold during various phases until about 2020.

Vista 360 looks forward to addressing the opportunities and challenges that lie ahead.

On September 1, 2010 which is also the effective date, the U.S. Nuclear Regulatory Commission finalized the transfer of the possession license for the Zion Nuclear Power Station from Exelon Generating LLC to Zion Solutions LLC. The Zion Nuclear Power Station is a two unit facility located 40 miles north of Chicago, IL on Lake Michigan.
