Re: Freedom of Information Act (FOIA) Request Letter to Nuclear Regulatory Commission (NRC)

Dear Ms. Sealing:

Pursuant to the Freedom of Information Act, 5 U.S.C. § 552, et. seq., we would like to obtain all documents relating to any inquiry by any entity (including but not limited to Jeffrey Parsons and Sheep Mountain Alliance) into the Colorado Department of Public Health and Environment (CDHPE)'s licensing of the Piñon Ridge Mill in Montrose, Colorado, from January 2007 to the present.

For purposes of this request, documents include, but are not limited to, all drafts and final reports, memoranda, policy, guidance, agreements, orders, data, and notes, including but not limited to notes related to the March 10, 2011 telephone conversation between Mr. Duncan White and Mr. Jeffrey Parsons and any follow-up telephone calls between those parties. Documents also include, but are not limited to, any and all correspondence, including email, between and among NRC personnel, including but not limited to Ms. Pamela J. Henderson, Ms. Deborah Jackson, Mr. Duncan White, and Mr. David McIntyre, and members of the public, or members of or counsel for Sheep Mountain Alliance, or citizens or employees of, or counsel for the Towns of Telluride and/or Ophir, Colorado. In referring to "counsel for Sheep Mountain Alliance" we mean to include Mr. Jeffrey Parsons and Mr. Roger Flynn, and any associate or employee of the Western Mining Action Project, as well as Mr. Travis Stills and any employee or associate of the Energy Minerals Law Center. In referring to "counsel for the Towns of Telluride and/or Ophir, Colorado," we mean to include Mr. Richard Webster, Mr. Matthew Wessler and any employee of Public Justice, P.C., as well as Mr. Kevin Geiger, and Mr. Stephen B. Johnson and any employee of the Stephen B. Johnson Law Firm, P.C.

Under applicable law pertaining to the Freedom of Information Act, we believe that these documents and items are available to us and other members of the public. If any portion of this request is denied, we request a detailed statement of the reasons for the withholding and an index or similar statement of the nature of the documents withheld pursuant to the Freedom of Information Act.
