1. The draft revision to COM-106 (NRR's office instruction on the TIA process) was sent out for comment via email by Nelson on Monday, November 28th. We are requesting any comments by January 6th, 2012.
2. Potential TIA regarding Seismic Assumptions at Point Beach is under review in NRR/DSS/SBPB.
3. NRR should be receiving the Quad Cities TIA on Tornado Missile Protection by the end of December.
4. NRR will be removing NRO from concurrence on the Watts Bar-Seismic Qualification of Heinemann Molded Case Circuit Breakers, and will proceed in issuing the draft to the region.
