SUBJECT: Response to Request for Additional Information Regarding Response
to Generic Letter 89-08, 'Erosion/Corrosion-Induced Pipe Wall
Thinning' (TAC No. 73496)

The subject generic letter requested us to provide information on the implementation of a long-term erosion/corrosion monitoring program for high-energy carbon steel systems at Indian Point Unit No. 2. We provided our response by letter dated July 20, 1989, which stated that our program meets the intent of the NUMARC guidelines described in Appendix A of NUREG-1344. A November 30, 1989 letter from D.S. Brinkman to S.B. Bram requested us to confirm that our program actually meets the NUMARC guidelines or to identify any exceptions to those guidelines and to describe how our program is equivalent.

The program described in our previous response is consolidated into a document entitled "Inspection Program to Monitor Erosion/Corrosion in Piping Systems at Indian Point Unit No. 2". A copy of this document is available for review at the station. We believe that the program described in this document does meet the NUMARC guidelines described in Appendix A of NUREG-1344.
