Dear Requester:

After reviewing your Freedom of Information Act/Privacy Act (FOIA/PA) request dated March 23, 2012, I have determined that the scope of the request is too broad and so wide-ranging as to be unreasonably burdensome on the agency if an attempt were made to conduct a search. The FOIA requires requesters to reasonably describe the records sought. Your request for any and all documentation for a Nuclear Regulatory Commission licensee without a specific timeframe or subject does not reasonably describe the records sought. Although an attempt was made by your assigned FOIA caseworker to get you to reduce the scope of the request, no agreement could be reached.

At this time, the request: **FOIA/PA-2012-00180** is being administratively closed. This determination may be appealed within 30 days by writing to the FOIA/PA Officer, U.S. Nuclear Regulatory Commission, Washington, DC 20555-0001. Clearly state on the envelope and in the letter that it is a "FOIA/PA Appeal." Should you desire to file another FOIA request, you may call or write the FOIA office to determine what additional information is needed from you to make your request more specific.
