This is in reference to your letter dated February 28, 2012 requesting to amend Nuclear Regulatory Commission License No. 52-01986-04. In order to continue our review, we need the following additional information:

1. You have requested to remove Mr. Jorge F. Ramos as the Radiation Safety Officer. Should Mr. Ramos remain as an authorized user in Condition 11 of your license?
2. You have proposed Dr. Guzman to be your Radiation Safety Officer. Should Dr. Guzman be listed as an authorized user in Condition 11 of your license? If he is to be listed, then for which materials should he be an authorized user?
3. You have proposed Dr. Guzman to be your Radiation Safety Officer. Please provide telephone number, facsimile number, and email address for Dr. Guzman.

If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.
