IMPORT OF NUCLEAR EQUIPMENT AND MATERIAL; EXPORT
OF INTERNATIONAL ATOMIC ENERGY AGENCY
SAFEGUARDS SAMPLES (10 CFR PART 110)

On April 13, 2012, the Executive Director for Operations (EDO) signed a Final Rule, effective 30 days after the date of publication, entitled, "Export and Import of Nuclear Equipment and Material; Export of International Atomic Energy Agency Safeguards Samples."
