Desc: I hereby request that a copy of the following information and/or documents be provided pursuant to the Freedom of Information Act.

Any and all documents pertaining to the asbestos-containing equipment, asbestos-containing machinery, asbestos-containing products, and asbestos-containing materials (hereinafter "ACM") installed during the construction of Unit #1 and Unit #2 of the Point Beach Nuclear Power Plant in Two Creeks, Wisconsin, during the 1967-1974 time period. This request includes, but is not limited to the following:

1. Equipment and Machinery Documents and Lists:

Please produce all documents (e.g., invoices, bills of lading, bill of materials, etc.) and/or a listing of all equipment and machinery (e.g., reactor, turbines, boilers, turbine generators, steam generators, condensers, demineralizers, pressurizers, liquid metal pumps, compressors, pumps, blowers, valves, generators, steam generators, heaters, superheaters, furnaces, fuel stokers, steam condensers, air heaters, evaporators, condensate pumps, feed water pumps, etc.) installed during the construction and/or maintenance of Unit #1 and Unit #2 at the Point Beach Nuclear Power Plant in Two Creeks, Wisconsin, during the time period 1967-1974.

For each specific piece of equipment and/or machinery identified in response to this request, please provide the following information: (1) the name of the manufacturer of each piece of equipment or machinery; (2) the brand name of each piece of equipment or machinery; (3) the model number of each piece of equipment or machinery; and (4) the ACM used on or in each piece of equipment or machinery.

2. Asbestos Containing Products Documents and Lists:

Please produce all documents (e.g., invoices, bills of lading, bill of materials, etc.) and/or a listing of all asbestos-containing products and ACM (e.g., asbestos-containing pipe insulation, asbestos-containing block insulation, asbestos-containing cements and mastics, asbestos-containing blankets and textile materials, asbestos-containing gaskets, asbestos-containing packing, asbestos-containing spray-on insulation, asbestos-containing gunning materials, asbestos-containing cement pipes, asbestos-containing refractory materials, asbestos-containing tape, asbestos-containing mineral wool, asbestos-containing transite boards, asbestos-containing wire, asbestos-containing cloth, asbestos-containing electrical components, raw asbestos, asbestos-containing and/or asbestiform talc, vermiculite, etc.) used in the construction and/or maintenance of Unit #1 and Unit #2 at the Point Beach Nuclear Power Plant in Two Creeks, Wisconsin, during the time period 1967-1974.

Please produce all documents and/or a listing of all contractors and subcontractors who participated in the construction and/or maintenance of Unit #1 and Unit #2 at the Point Beach Nuclear Power Plant in Two Creeks, Wisconsin, during the time period 1967-1974. Please provide a separate listing and/or documents pertaining to all contractors and subcontractors who performed insulation and/or masonry related services in the construction and/or maintenance of Unit #1 and Unit #2 at the Point Beach Nuclear Power Plant in Two Creeks, Wisconsin, during the time period 1967-1974.

4. Suppliers/Distributors

Please produce all documents and/or a listing of all Suppliers and/or Distributors of the equipment, machinery, asbestos-containing products and ACM identified in response to Request Number 1 and Request Number 2 above.

Please be advised that I am not seeking blueprints, plans, schematics, construction engineering plans, architectural drawings, etc., related to the construction, maintenance or logistics of Unit # 1 and Unit # 2 of the Point Beach Nuclear Power Plant located at Two Creeks, Wisconsin. Further, I am not seeking information related to the configuration, layout or operation of Unit # 1 and Unit # 2 of the Point Beach Nuclear Power Plant located at Two Creeks, Wisconsin. I understand that these documents could contain information that may pose a threat to national security.

I am merely seeking information regarding the asbestos-containing equipment, asbestos-containing machinery, asbestos-containing products and asbestos-containing materials used in the construction and maintenance of Unit #1 and Unit #2 at the Point Beach Nuclear Power Plant in Two Creeks, Wisconsin, during the time period 1967-1974, in order to determine the asbestos-containing equipment, asbestos-containing machinery, asbestos-containing products and asbestos-containing materials that my client was exposed to while working at Unit #1 and Unit #2 of the Point Beach Nuclear Power Plant in Two Creeks, Wisconsin, during the time period 1967-1974.
