SUBJECT: SUMMARY OF THE MAY 24, 2012, NON-PUBLIC MEETING TO DISCUSS
END-OF-CYCLE SECURITY PERFORMANCE OF FERMI POWER PLANT,
UNIT 2, FOR CALENDAR YEAR 2011

Dear Mr. Davis:

On May 24, 2012, the U.S. Nuclear Regulatory Commission (NRC) held a Non-Public Meeting at the Fermi Power Plant, Unit 2, located at 6400 North Dixie Highway, Newport, Michigan. The purpose of the meeting was to discuss the NRC End-of-Cycle assessment of the Fermi Power Plant, Unit 2, security performance for the 2011 calendar year. The results of that assessment were discussed in a letter to the licensee dated March 5, 2012, (ADAMS Accession Number ML12065A400).

The NRC opened the meeting with an overview of the NRC, the NRC's Reactor Oversight Process (ROP), national ROP results in the area of security, and the Action Matrix. This was followed by a summary of the NRC's assessment of Fermi Power Plant, Unit 2, security performance for the 2011 calendar year. A list of principal meeting attendees can be found in the attached enclosure.

Following the completion of the NRC's presentation and remarks, the licensee was afforded the opportunity to provide any response and remarks. After the conclusion of the licensee's remarks, NRC officials adjourned the meeting.
