I wanted to inform you that the NRC mistakenly included the Strata enclosure in the status update letter sent to Mr. Maynahonah, Chairman of the Apache Tribe of Oklahoma. Because the Apache Tribe of Oklahoma declined to be a consulting party for the Ross Project (ML11336A224), the NRC did not intend to include the Strata enclosure in this tribe's status update letter. For that reason, Strata did not receive a copy of the letter to Mr. Maynahonah. I have attached a copy of the letter for your information (Package: ML12139A211). The NRC does not plan to send the Strata enclosure to the Apache Tribe of Oklahoma with its future status update letters.
