

The purpose of this modification is to increase the obligated amount by \$134,000 from \$30,000 to \$164,000. Accordingly, paragraph (b) of section A.3 of the task order entitled: "Consideration and Obligation--Cost Reimbursement - No Fee (AUG 2011) Alternate I (AUG 2011) is revised to read as follows:  
" (b) The amount presently obligated by the Government with respect to this contract is \$164,000.00. The original obligation of \$30,000 satisfied the minimum guarantee for the base contract."
