Subject: Reciprocal Activities in Rhode Island/Agreement with Geisser Engineering

I called Mr. Bouramia to ask a few questions that came up during my May 9, 2012 inspection of Geisser Engineering in Rhode Island. Specifically I wanted to find out more about the sale of the company from Geisser to Mr. Bouramia and if any agreements were in place for conducting licensed activities in areas of exclusive Federal jurisdiction.

Mr. Bouramia stated that he bought the Vermont portion of Geisser Engineering in May 2008. He sent an amendment letter requesting a name change, and according to him, an ownership change as well. I mentioned that there was no record indicating a change of ownership. Although his intention was not clear at the time, additional information submitted to the RI office shows a definite change of ownership in May 2008 from Geisser Engineering to Vermont Testing and Consulting Corporation (VT).

I asked Mr. Bouramia if he had any written agreements with Mr. Geisser to conduct licensed activities in areas of exclusive Federal jurisdiction. Mr. Bouramia stated that there was no written agreement but an oral agreement in place. The agreement was, if there was licensed activity to be performed in an area of exclusive Federal jurisdiction, Mr. Geisser would contact VT ahead of time to ensure that VT personnel could be physically present at the temporary job site and ensure that VT policies and procedures were followed.

I thanked Mr. Bouramia for his time and ended the call.

I emailed Mr. Bouramia the details of our conversation and my documentation request immediately after the call.

NOTE: Mr. Bouramia submitted his documents related to the incorporation of his company in Vermont in the 2 weeks following the initial phone call.
