NORTH ANNA UNIT 3 COMBINED LICENSE APPLICATION
SRP 13.06.01: RESPONSE TO RAI LETTER 89

On November 9, 2011, the NRC requested additional information to support the review of certain portions of the North Anna Unit 3 Combined License Application (COLA) which consisted of seven questions. The responses to the requests for additional information (RAIs) were provided in letters dated December 16, 2011 (Serial Nos. NA3-11-062R and NA3-11-062RA).

In the response to RAI question 13.06.01-58, which addressed target set selection, Dominion committed to revise the North Anna Power Station Unit 3 Physical Security Protection Systems Report (PSPSR) by February 29, 2012. However, on February 23, 2012, M. Takacs, the NRC's North Anna Unit 3 Security Project Manager, informed Dominion that because of changes to the standard plant layout based on final seismic design, MHI Technical Report UAP-SGI-08002 US-APWR High Assurance Evaluation Assessment Report (HAE) was being revised. This revision affects the information provided in the PSPSR.

It was agreed that the PSPSR would be submitted after MHI submits its revision to the HAE, which is scheduled for October 31, 2012. In addition, Dominion submitted a Seismic Closure Plan to the NRC on May 29, 2012, which also affects the information in the PSPSR. The revision to the PSPSR will be provided to the NRC in accordance with Dominion's Seismic Closure Plan.

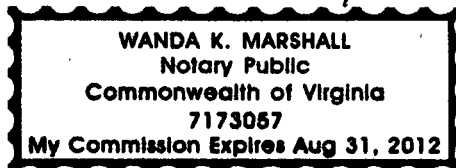
