SUBJECT: CLOSURE OF INVESTIGATION (OI 4-2011-038)

Dear Mr. Perito:

This letter refers to the investigation conducted by the NRC's Office of Investigations regarding activities at Grand Gulf Nuclear Station, which was completed on January 10, 2012. The investigation was conducted to determine whether a radiation protection technician, employed as a contractor at Grand Gulf Nuclear Station, willfully provided inaccurate information in a resume.

Based on the evidence gathered during the investigation, the NRC determined that there was not sufficient evidence that the radiation protection technician acted deliberately or acted with careless disregard when stating qualifications on their resume. Therefore, no willful aspects were determined and no violation was identified.

Since the investigation determined that there was no willfulness, the NRC is not taking any enforcement action against Entergy Operations. However, the previously issued noncited violation, which was dispositioned in Grand Gulf Nuclear Station Integrated Inspection Report 05000416/2011002, for the failure to use a qualified radiation protection technician to provide direct continuous coverage of work in a locked high radiation area will remain unchanged.
