1. On page 3, Section B.3 CONSIDERATION AND OBLIGATION-MIXED CONTRACT TYPES, revise paragraphs (b) and (c) as follows:

b. The total price for the base year, option year 1, and option year 2 is \$1,020,332 (CLINS 001-043) of which \$841,216 is for the firm fixed price portion and \$179,116 is for the cost reimbursement portion.

c. The amount currently obligated by the Government is \$553,000.

2. On page 13 of the Statement of Work, Promotional Plan, this task is changed to an Optional Task and the contractor must receive written authorization from the NRC's Contracting Officer's Representative prior to developing paid promotional plans.

All other terms and conditions of the subject contract remain unchanged.
