
The ISFSI Physical Security Plan is established as Addendum III to the LACBWR Physical Security Plan. Chapter 6 of Addendum III is revised to enhance physical search requirements and clarify the facility badge system. Appendix II to the ISFSI Physical Security Plan is also revised to include enhanced physical search requirements in Task 47.

Also enclosed, as a separate item, is an explanation of the changes. These changes do not decrease the effectiveness of the Security Plan and do not decrease any commitment to security. The changes strengthen the overall security of the spent fuel by incorporating additional commitments to 10 CFR 73.55.
