Certification of Substance Abuse Experts, Petition for Rulemaking; Consideration in the Rulemaking Process; 10 CFR Part 26 (Docket No. PRM-26-7; NRC-2011-0220)

On June 7, 2012, the NRC published in the *Federal Register* (77 FR 33619) a document to consider the issues raised in petition for rulemaking (PRM) PRM-26-7, submitted by the American Academy of Health Care Providers in the Addictive Disorders, in the rulemaking process. The petitioner requested that the NRC amend its regulations to include the Academy as one of the organizations authorized to certify a substance abuse expert. The NRC determined that the issues raised in the PRM are appropriate for consideration and will consider them in the ongoing Title 10 of the Code of Federal Regulations Part 26 Technical Issues rulemaking. The docket for PRM-26-7 was closed on June 7, 2012.

Site Audit at Duane Arnold Energy Center

On May 30 and 31, 2012, the staff and NRC contractors conducted a site audit at the Duane Arnold Energy Center to support review of the National Fire Protection Association Standard (NFPA) 805 license amendment, specifically relating to the licensee's use of fire modeling in their analysis. The staff and contractors performed walk downs of selected plant fire areas, conducted interviews with licensee personnel and reviewed detailed fire modeling input data.

Public Meeting Held on the Cumulative Effects of Regulation Process Changes

On May 31, 2012, the staff held a Category 3 public meeting on the Cumulative Effects of Regulation (CER) process changes. Representatives of the nuclear power industry, agreement states, and materials/fuel facilities participated both in person and remotely via teleconference and webinar. The staff obtained feedback on several CER-related topics, and will incorporate that feedback into the October 2012 Commission paper describing the staff's final strategy to implement the process changes.

Virgil C. Summer (VC) Nuclear Station (NFPA) Standard 805 Regulatory Audit

During the week of June 4, 2012, the staff conducted an NFPA 805 regulatory audit at the VC Summer Nuclear Station. The audit team reviewed NFPA 805 transition documents related to VC Summer's NFPA 805 license amendment request. VC Summer's staff and their contractors conducted presentations, technical discussions, and plant tours to help the audit team understand their fire protection program.

Publication of Regulatory Guide 8.24, "Health Physics Surveys During Enriched Uranium-235 Processing and Fuel Fabrication"

On June 5, 2012 the staff published Revision 2 of Regulatory Guide 8.24, "Health Physics Surveys During Enriched Uranium-235 Processing and Fuel Fabrication" (77FR 33253). This regulatory guide was revised to describe methods acceptable to the NRC staff for implementing specific parts of the agency's regulations in 10 CFR 20.1501(a). The guide also describes techniques that the staff uses in evaluating specific problems or postulated accidents, and identifies data the staff needs in its review of applications for permits and licenses.

Withdraw of Regulatory Guide 8.33, "Quality Management Program"

On June 5, 2012, the staff withdrew Regulatory Guide 8.33, "Quality Management Program" (77 FR 33253). This regulatory guide provided guidance to materials licensees to help to ensure that the objectives of the former NRC "Quality Management Program" regulations were met. However, the requirement to establish a Quality Management program was deleted from the regulations as part of an overall revision in 2002 of the of the "Medical Use of Byproduct Material" regulations (10 CFR part 35). Therefore, the guidance provided in RG 8.33 is no longer accurate or current and is being withdrawn through this notice.
