The purpose of this modification is to exercise option year 1 of the contract, hereby increasing the obligated and ceiling amounts. The obligated amount is incrementally funded by \$18,000 from \$119,000 to \$137,000 and the ceiling amount is hereby increased by \$129,468.40 from \$151,198.76 to \$280,468.40.
