Dear Mr. Bush:

Enclosed is Amendment No. 05 to your NRC Material License No. 13-32359-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Please note that License Condition 22 regarding the decommissioning financial assurance requirement has been removed from your license because this condition is not applicable to the scope of your program.

In addition, it has come to our attention that omissions existed in Amendment No. 04 of your license issued on November 19, 2010. These omissions have been corrected by revising entirety License Condition 22 regarding the requirements of Increased Control Order and Fingerprinting Order; and by adding new License Conditions 23 and 24 regarding the testing of the on-off mechanism (shutter) and the requirement for modifications involving the sealed sources, respectively. These changes are in bold font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. 
