On June 11, 2012, Westinghouse Electric Company (WEC) and Ameren Missouri senior personnel visited the U.S. Nuclear Regulatory Commission (NRC) Headquarter for a drop-in meeting with the Office of New Reactors/Division of Advanced Reactors and Rulemaking Management. The purpose of the meeting was to give NRC an update on WEC and Ameren's current partnership and plans regarding the Westinghouse small modular reactor (SMR) design.

The WEC and Ameren presentation, which was discussed during the drop-in meeting, is available to the public through the Agencywide Documents Access and Management System (ADAMS) accession number ML12171A043.
