DESCRIPTION OF MODIFICATION:

The purpose for modification number 003 is to:

1. Increase CLIN 2005-Travel;
2. Provide incremental funding in the amount of \$40,000.00;
3. Change the COR designated on the contract.

As a result of this modification:

1. CLIN 2005 – Travel is increased by \$5,500.00 thereby increasing the ceiling of the contract by \$5,500.00 from \$557,251.00 to \$562,751.00;
2. Funds in the amount of \$40,000.00 are obligated thereby increasing the obligated amount from \$185,000.00 to \$225,000.00,
3. To change the certified COR designated on the contract from DaBin Ki to Amy D'Agostino.
