By letter to the U.S. Nuclear Regulatory Commission (NRC) dated April 17, 2012 [ML12150A1460], United Nuclear Corporation (UNC) submitted a license amendment request revisions to several groundwater protection standards in Condition 30.B Source Material License SUA-1475. UNC proposes to apply updated background concentrations to all three of the hydrostratigraphic units at the site.

The NRC staff has completed its acceptance review of your application to amend your license and identified no significant administrative omissions or major technical deficiencies. Therefore, this request has been accepted for formal review. Please note that an acceptance review does not constitute a complete technical review, and that a technical review may identify omissions in the submittal that may require additional information. Based on our current review schedule, we anticipate completing this review of the license amendment request by August 2012. This date could change, depending on the findings of our technical review, urgent assignments, or other factors. We will promptly communicate any significant changes to this schedule.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice for Domestic Licensing Proceedings and Issuance of Orders," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of the NRC's Agencywide Documents Access and Management System (ADAMS).
