The meeting afforded the stakeholders the opportunity to ask the NRC staff clarifying and amplifying questions on the ISG, and to discuss the Significance Determination Process (SDP). The meeting was not designed nor intended to solicit comments on the ISG.

The meeting consisted of the NRC staff making a presentation (Agencywide Documents Access and Management System (ADAMS) Accession No. ML12170A013), which started with how public comments could be submitted to the NRC on the ISG. The staff next discussed the background for the development and issuance of the Order and the ISG. Next, the NRC staff discussed the assessment process contained in the implementation guidance, NEI 12-06, "Diverse and Flexible Coping Strategies (FLEX) Implementation Guide, Revision B1, which was submitted on May 13, 2012 (ADAMS Accession No. ML12143A232) for the purpose of compliance with the Order. The NRC staff discussed the endorsement of the NEI document and the exceptions which are contained in the ISG (ADAMS Accession No. ML12146A014). Also, the NRC staff discussed the reporting requirements from the Order and the section in the ISG which provides some details as to what is expected in the licensee submittals.

Lastly, the NRC discussed the SDP process, which has been implemented for the B.5.b Order, and how it could be updated to be used for Order EA-12-049.
