Reference: R. R. Sgarro, (PPL Bell Bend, LLC) to U.S. Nuclear Regulatory Commission (NRC), "Schedule Information for Responses to Requests For Additional Information for the Bell Bend FSAR," BNP-2012-072, dated March 14, 2012.

The purpose of this letter is to provide updated schedule information for the PPL Bell Bend, LLC (PPL) responses to Requests for Additional Information (RAIs) 37 and 107, which involve FSAR Section 3.7.


Enclosure 1 provides an updated schedule for PPL's responses to certain questions associated with these RAIs that were previously forecast for submittal on or before March 15, 2014. This was based on a conservative evaluation of the work at the time, given the uncertainty associated with new requirements that PPL needed to address, e.g., the revised EPRI/NRC/DOE Central and Eastern United States Seismic Source Model.

Based on our ongoing re-evaluation of these tasks, the March 15, 2014 submittal date has been reforecast for September 13, 2013, an improvement of six months.

The only regulatory commitments in this correspondence are to submit the responses to the RAI questions in Enclosure 1 on or before September 13, 2013.
