PROGRAM SCOPE

The licensee is a cardiology clinic located in Terre Haute, Indiana. The licensee is authorized to use licensed material permitted by Title 10 Code of Federal Regulations 35.200. The licensee is staffed with one full-time nuclear medicine technologist. The cardiology clinic performs approximately 4 diagnostic cardiology procedures per day using Tc99m from the local nuclear pharmacy in the form of unit doses. The licensee obtained an outside consultant to perform program audits, instrument calibrations, and radiation safety training. The licensee is operational on Monday, Wednesday, and Friday.

Performance Observations

The inspection consisted of interview with licensee personnel, a review of select records, tour of the nuclear medicine department and independent measurements. Interviews conducted with the technologist revealed an adequate level of understanding of emergency and material handling procedures and techniques. Dose calibrator constancy checks, daily surveys, and package receipt were successfully demonstrated and observed by the inspector. The inspector observed two administrations of licensed material. No violations of NRC requirements were identified.
