

The purpose of this modification is to increase the Maximum Ordering Limitation by \$86,725 to allow for increases to Task Orders No. 2, 3, and 5.

Accordingly, the following change is hereby made:

1. Section B.3 CONSIDERATION AND OBLIGATION--TASK ORDERS (AUG 1989) ALTERNATE 1 (JUN 1991) is revised as follows:
