On June 6, 2012, the U.S. Nuclear Regulatory Commission (NRC) staff held a conference call with General Electric-Hitachi Nuclear Energy (GEH) staff to discuss resolution of open items and outstanding requests for additional information (RAI) responses resulting from the steam dryer audit in support of the safety review of the GEH Economic Simplified Boiling-Water Reactor (ESBWR) Design Certification (DC).
