"Safely Speaking" Contract

On June 22, 2012, as a result of a competitive General Services Administration Schedule solicitation, a fixed price contract (NRC-HQ-12-C-38-0076) was awarded to Employee Learning Innovations, Inc. of Atlanta, GA. This contract will provide qualified instructors to teach NRC staff and managers on "how to effectively listen to safety concerns within a nuclear/industrial environment and respond appropriately." The courses are to be provided at the NRC's Professional Development Center or in any of NRC's regional facilities. The period of performance is June 22, 2012, to June 21, 2013. The total estimated value of the contract is \$150,000.

Access Authorization Fees; Direct Final Rule; Confirmation of Effective Date; 10 CFR Parts 11 and 25 (RIN 3150-AJ00; NRC-2011-0161)

On June 22, 2012, the NRC published a notice in the *Federal Register* (77 FR 37553) confirming the effective date of June 22, 2012, for the direct final rule that it published in the Federal Register on May 3, 2012 (77 FR 26149). The direct final rule amended the NRC's access authorization fees charged to licensees for work performed under the Material Access Authorization Program (MAAP) and the Information Access Authority Program (IAAP).

Employee Assistance Program (EAP) Contract

On June 26, 2012, as a result of a competitive General Services Administration Schedule solicitation, a firm fixed price order (GS02F0037P/NRC-HQ-12-F-38-0002) was awarded to EAP Consultants, Inc. of Marietta, GA. The contractor will provide services and personnel necessary to operate a turnkey EAP program and EAP Website. The period of performance is July 1, 2012, to June 30, 2013, with four 1-year options. The total estimated value of the contract is \$767,415, inclusive of all options.

Groundwater Protection Workshop Attendance

On June 25-29, 2012, staff attended a radioactive effluents and groundwater protection workshop. Staff discussed developments related to radioactive effluents and groundwater protection that have occurred over the last year. Staff also led an NRC Panel Discussion, which included NRC Health Physics Inspectors from all four regions. The purpose of the panel was to engage stakeholders and to provide clarity and awareness of the NRC regulatory program for groundwater protection and radioactive effluents.

Pre-licensing Meeting with Comanche Peak

On June 26, 2012, staff supported a public pre-licensing meeting with the Comanche Peak Nuclear Power Plant licensee to discuss an anticipated request for two, one-time Technical Specifications changes for 14-day allowed outage times (AOTs) on a startup transformer. The purpose of the extended AOT application is to install a backup transformer to enhance the reliability of offsite power. Power for both operating units will be supplied by the 345kV switchyard during the AOT. The application is expected by September 2012.

Staff Issues Indian Point Nuclear Generating Unit Nos. 2 and 3 License Renewal Draft Supplement to the Final Supplemental Environmental Impact Statement for Public Comment

On June 26, 2012, the staff issued for public comment a draft supplement to NUREG-1437, "Generic Environmental Impact Statement for License Renewal of Nuclear Plants, Supplement 38, Regarding Indian Point Nuclear Generating Unit Nos. 2 and 3." This draft supplement updates the document based on information regarding the units of impingement and entrainment data provided by the applicant, revises the conclusions regarding thermal impacts based on newly available thermal plume studies, and updates the status of the NRC's consultation under Section 7 of the Endangered Species Act with the National Marine Fisheries Service regarding the short nose sturgeon and Atlantic sturgeon. The public comment period ends on August 20, 2012.
