SUMMARY

We have reviewed your letter dated March 12, 2012, with attachments, requesting an amendment to your byproduct materials license and find that we need additional information as follows:

- 1. For each diagram submitted, please add a notation of the address of use being closed out, and the identity of the area(s) of use being closed out. In the absence of clear markings, it is difficult for us to determine this information.**
- 2. For the location at 1819 Carew St., Fort Wayne, Indiana, a notation is made that the sealed sources were transported to 11108 Parkview Circle by a commercial nuclear pharmacy. However, no other information concerning the integrity or identity of the sealed sources was made.**

Please specify which sealed sources were transported to the other location of use and provide a copy of the most recent leak test (preferably prior to transfer) for each sealed source to demonstrate that it was not leaking at the time of transfer.

- 3. For the 1819 Carew St. location, on the "Close-out Survey" sheet, it states that the survey was performed on March 12, 2012. In another section on the same form it states that the survey was performed with a "Ludlum survey meter model 14C with end window probe s/n 47649 calibrated on 5-18-12....."**

Please explain this discrepancy, which appears to be a typo, as it appears the survey was performed on March 12, 2012, using a survey instrument calibrated more than two months later than this date.

Please also be reminded of the provisions in 10 CFR 30.9(a), "Completeness and accuracy of information,"..."(a) Information provided to the Commission by an applicant for a license or by a licensee or information required by statute or by the Commission's regulations, orders, or license conditions to be maintained by the applicant or the licensee shall be complete and accurate in all material respects."

ACTION REQUIRED

1. Submit the requested information, with an appropriate business letter for transmittal, within 10 calendar days (by June 15, 2012) by referencing control number 577247 to facilitate proper handling in our office. Please contact me if you need to make alternative response arrangements.

If we do not receive an adequate response by this date, we may either void or partially issue this amendment without attempting to contact you further and without prejudice to resubmission of your request and responses at a later date.

Upon receipt of your response we will reactivate placement of your request in our database and resume our review. Address your written response, via an appropriately dated and signed (by management) cover letter, to my attention at the above address.


