

Funding in the amount of \$6,976.00 is hereby obligated. This funding consists of the following breakdown: Cost: \$6,466.00 and Fee: \$510.00. Funding for cost is hereby increased by \$6,466.00 from \$131,210.00 to \$137,676.00. Funding for fee is hereby increased by \$510.00 from \$10,446.00 to \$10,956.00. The total ceiling remains at \$148,632.00. 2. Section A.2 Consideration and Obligation - Cost Plus Fixed Fee - Part (c) is hereby revised as follows: "The amount currently obligated by the Government with respect to this contract is \$148,632.00, of which the sum of \$137,676.00 represents the estimated reimbursable costs, and of which \$10,956.00 represents the fixed fee."
