This refers to your license amendment request submitted on July 3, 2012. Enclosed with this letter is the amended license adding and removing authorized user (AU) physicians.

Please note that the 35.300 authorizations for the new AUs were limited to oral administration of sodium iodide I-131, based on the limitations in Items 6C and 9C of your license. This was discussed with Peggy Pust of your staff in a telephone conversation on July 5, 2012.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
