Mr. Wimmer:

Assuming this accurately reflects the entity that has control over your licensed activities, we will use the same address as the IEMA license. Let us know if this is not the case.

As long as your Texas possession and use license remains valid, you can distribute from one or both locations. Given that you plan to have some overlap, your exempt-distribution license should show both. Condition 11 on the license can be written as follows:

“The licensee is authorized to distribute only from its facilities located at Route 41 and Martin Luther King Jr. Drive, North Chicago, Illinois, and at 1921 Hurd Drive, Irving, Texas.”

If you anticipate making any distributions from the Texas location in the future, it would not be necessary to remove it from your exempt-distribution license. If you want to remove the Texas location (or if your Texas license is allowed to expire), then you should submit another amendment request. This is a simple process; you need only send us a request to amend your license to “...remove the distribution location at 1921 Hurd Drive, Irving, Texas...” or words to that effect.

I hope this adequately responds to your questions. Let me know if you need additional information.

Our IEMA license address is as written below. However, the actual address of where the material would be distributed from will be different. Also, presuming that we will be given authorization to distribute from Illinois, is there a overlap time for the license where we can distribute from Texas until we transfer the material to Illinois? Or how do we handle the interim? It will take us several weeks to move the operation to Illinois.
