NOTIFICATION OF NPDES PERMIT NO MI0005827 NON COMPLIANCE

In a letter dated June 15, 2012, Indiana Michigan Power Company (I&M), the licensee for Donald C. Cook Nuclear Plant (CNP) Units 1 and 2, submitted a notification of non compliance to the Michigan Department of Environmental Quality. The non compliance was a failure to obtain a Reverse Osmosis System Reject weekly sample for Total Suspended Solids during the reporting week May 27, 2012, through June 2, 2012.

This notification is made pursuant to Cook Nuclear Plant's NPDES Permit MI 0005827, Part II. Section C. 6.b, Noncompliance Notification - Other Reporting.

During the reporting week of May 27 - June 2, 2012, we failed to obtain a Reverse Osmosis System Reject (Outfall 00G) weekly sample for Total Suspended Solids during a discharge period. Reverse Osmosis Reject flow Total Suspended Solids samples taken on May 15, and June 8 were both <4.0 ppm. This noncompliance does not pose a threat to the environment, public health, or safety.

A new process has been introduced that requires a review near the end of the week to ensure that all permit related analyses have been completed.


