The purpose of this modification is to:

1. Exercise the Government's unilateral right to exercise an option in accordance with the contracts clause FAR 52.217-9, Option to Extend the Term of the Contract. Accordingly, the full contract period of performance is changed to read:

"March 13, 2012 – September 25, 2013".

The Government hereby exercises Option No. 1 at the rates priced in Section B of the contract.

2. Increase the task order ceiling by \$3,421,594.10, from \$691,634.63 to **\$4,113,228.73** Accordingly, paragraph (a) under section B.4 Consideration and Obligation-Time and Materials Contract (August 2011) is revised to read as follows:

*"(a) Currently, the ceiling price to the Government for full performance under this contract is **\$4,113,228.73**."*

3. Increase the total obligated amount by \$800,000.00 from \$513,000.00 to \$1,313,000.00 Accordingly, paragraph (c) under section B.4 Consideration and Obligation-Time and Materials Contract (August 2011) is revised to read as follows:

"(c) The amount presently obligated by the Government with respect to this contract is \$1,313,000.00."
