The purpose of this modification is to close the task order since all work has been completed, to deobligate remaining amount and decrease the ceiling by \$137.65 from \$159,644.75 to \$159,507.10. "a. The total not to exceed cost to the government for the full performance of this order is \$159,507.10.
