Dear Mr. Lanier:

This is in reference to your letter dated April 13, 2012 (ADAMS Accession No. ML12122A841), notifying the NRC that during a recent audit of your radiation safety program, you identified that the required transfer of byproduct materials annual report for calendar year 2010 was not submitted to the NRC in accordance with 10 CFR 32.12. This also refers to your letter dated May 9, 2012 regarding the 2011 annual report.

Based on the results of an in-office review of your notification and in accordance with the NRC Enforcement Policy, the NRC has determined that a violation of NRC requirements occurred. A Non-Cited Violation (NCV) is enclosed that categorizes this violation as a Severity Level IV. Please retain the enclosed NRC Form 591M Part 1 in your files. You are not required to respond to this letter.

If you contest the violation or significance of the NCV, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001, with copies to: (1) the Regional Administrator, Region 1; and (2) the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter, its enclosure, and your response, if you choose to provide one, will be made available electronically for public inspection in the NRC Public Document Room or from the NRC document system (ADAMS), accessible from the NRC website at <http://www.nrc.gov/reading-rm/adams.html>.
