# Update Report 72-9/2012-01 FSV ISFSI Physical Protection Plan

## Introduction

The Department of Energy's Idaho Operations Office (DOE-ID) was issued license SNM-2504 to operate the Fort St. Vrain (FSV) Independent Spent Fuel Storage Installation (ISFSI). As part of the license issuance, DOE-ID's Physical Protection Plan for the FSV ISFSI was approved by the Nuclear Regulatory Commission (NRC).

Pursuant to 10 CFR 72.44, License Conditions, paragraph (e), DOE-ID has made changes to its NRC-approved Physical Protection Plan without NRC approval. The criteria DOE-ID used for approving these changes were: (1) no change resulted in a decrease in effectiveness of the Physical Protection Plan and (2) compliance with the applicable regulations and the FSV ISFSI Technical Specifications are maintained.

## Description of Changes

The changes resulted from the need to update the document for editorial reasons and are described below. The copy of the updated document is also being provided to Region IV.
