Enclosed is Amendment No. 04 renewing your NRC Material License No. 24-32318-01 in accordance with your request.

Please note that we have issued your license renewal with an expiration date of one year, in regards to letters dated December 29, 2010 and December 30, 2012 and several telephone conversations between Matthew Cushman and me from February 2012 through May 2012, indicating that you are in the process of terminating your NRC license. In addition, you indicated in a June 5, 2012 telephone conversation that you are in the final stages of disposing of your radioactive licensed materials and completing the termination process.



The NRC's Safety Culture Policy Statement became effective in June 2011. You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
