SUBJECT: AMENDMENT 14 - REVISED LICENSE APPLICATION DATED MARCH 20, 2012

Dear Mr. Couture:

In accordance with the submittal to revise the License Application dated June 29, 2012, and pursuant to Part 70 to Title 10 of the *Code of Federal Regulations* (10 CFR), Materials License SNM-1107 is hereby amended to include the revised license application.

Safety Condition S-1 has been revised to reference Revision 2.0 of the updated license application and the response to the requests for additional information. An incorrect reference has also been removed. The S-1 Condition now reads as follows:

S-1 Authorized Use: For use in accordance with statements, representations, and conditions in the license application, dated June 27, 2007; or as revised, pursuant to 10 CFR 70.32 or 10 CFR 70.72, and the supplements, dated July 18, 2007; September 13, 2007; April 21, 2008; June 10, 2008; September 30, 2008; August 30, 2010; October 4, 2010; September 7, 2010; November 22, 2010; December 15, 2010; February 22, 2011; April 8, 2011; and April 28, 2011; license application (Revision 2.0) dated June 29, 2012, and letter dated June 29, 2012.

The S-5 condition now appears in Revision 2.0 of the License Application dated June 29, 2012. Therefore, the S-5 condition has been removed from the license.

All other conditions of this license shall remain the same. Enclosed are copies of the revised Materials License SNM-1107 and the Safety Evaluation Report.

This letter concludes the action on Amendment 14 and closes the assigned Technical Assignment Control Number L33215.

This letter transmits security-related information, and is accordingly marked as Official Use Only. Upon removal of Enclosure 1, it is decontrolled. In accordance with 10 CFR 2.390 of the U.S. Nuclear Regulatory Commission's (NRC's) "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records System component of the NRC's Agencywide Documents Access and Management System (ADAMS).
