On June 8, 2012, Westinghouse Electric Company (Westinghouse) submitted its Columbia Fuel Fabrication Facility's triennial decommissioning funding plan update. On June 18, 2012, a Technical Assistance Request was submitted to the Special Projects Branch (SPB) by the Office of Nuclear Materials Safety and Safeguards. During the review, the SPB staff identified missing documentation to include the certification of financial assurance statement and contingency factor of 25% in the cost estimate. Per a phone conversation on July 13, 2012, Westinghouse agreed to submit supplemental information for the missing certification statement and a letter to clarify the contingency factor of 25% and add that amount to the cost estimate in the DFP submittal. Westinghouse was made aware that not submitting the supplemental documentation would result in requests for additional information for those two items. Based on the existing submittal and agreement from Westinghouse to submit the supplemental information requested, the SPB staff has determined that the DFP submittal is acceptable for a detailed review.
