DESCRIPTION OF MODIFICATION:

The purpose for modification number 009 is to:

1. Provide incremental funding in the amount of \$8,000.00.

As a result of this modification:

1. **Consideration and Obligation – TASK ORDERS (AUG 1989) (b)**, delete in its entirety and replaced with the following:

(b) The amount presently obligated with respect to this Task Order is \$130,707.00. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time exceed the contract ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract.
